# Financial Status Current Status

Professional Development is higher than anticipated due to additional classes taken by teachers. The internet service cost which was previously covered by the state is also higher than anticipated. Currently we are anticipating a small surplus which will be returned to the towns after the audit.

Chester – The budget was approved. The Board of Education, Board of Finance and Board of Selectmen came together with a shared understanding of what is important.

Deep River – The budget was approved. Ms. Andrews thanked Ms. Grow and the Board for their hard work on the budget. There are many end of the year activities in the next month. Dr. Andrea Ricci recently received the Connecticut Reading Association's Outstanding Reading Educator Award. The media specialist will be retiring.

Essex – The budget was approved. The Memorial Day celebration was held inside. Over the summer the configuration of the front office will be changed for security enhancements. Funds will be used from the sinking fund.

Region 4 – The budget was approved. This has been a good year for Region 4. The block scheduling will be a good change for the students. There is an opportunity to have Chinese students this summer for two weeks and up to 4 students for the next school year. The innovative manufacturing program will be expanded and valuable for students. A Therapeutic Clinical program was approved for the high school. The NEASC accreditation was received.
